# INTRODUCING KIRK DAVIS, NOMINEE FOR PRESIDENT

#### BACKGROUND

Bob Davis Electric is Shreveport's oldest operating electrical contractor and does work throughout Louisiana and East Texas. The company covers all areas of electrical services, specializing in residential, commercial, and light industrial with an emphasis on power requirements for telecommunications companies, generator installations, and retail maintenance.

#### INVOLVEMENT WITH NECA

Bob Davis Electric joined NECA in 1923. Since then, the company has been actively involved with NECA at the local and national level. Kirk Davis became involved when he attended his first national convention in 1979 in San Francisco.
