*Upon motion duly made and seconded, the Board approved the 15 nominees for induction into the Academy on Sunday, October 13, 2013 in Washington, DC at the opening General Session of the NECA Convention.*

In addition to those favorably reviewed for the second time at this meeting, the Jury also reviewed 15 nominations for their first reading. All nominations were approved and will be reviewed at next year's meeting.

Irvin also reported on a suggestion from the Jury of Fellows to eliminate the requirement for signatures on the nomination forms. It is believed that this would help to streamline the process. Signatures would continue to be required on the letters of nomination and recommendation.

#### **SECRETARY'S REPORT**

Thompson reported on the attendance at this meeting. The number of attendees exceeded the previous year until a few last-minute cancellations reduced the number to 84 Fellows and 73 spouses. The 157 total equals last year's attendance at the Broadmoor.

Thompson introduced a proposal to amend the Academy Rules that was properly submitted, distributed to the directors in a timely fashion. Thompson discussed the process and history of past changes to the Rules, as well as a summary of the proposed changes. A copy of the proposal showing the changes is attached to these minutes.

Thompson shared a report on the history of national and chapter staff that have been inducted into the Academy since its inception. The report also included whether staff was eligible for induction via action by the Jury, National Award Winner or National Officer. No action was requested or taken on this topic.
