Our HISTORY

It would take some time for the fledgling electrical construction industry to address all these concerns, but movement in this direction began before the 20th century commenced. By 1899, an organization representing six associations of electrical contractors within the state of New York was formed – the United Electrical Contractors of New York State.

In early 1901, the New York group was preparing for its convention at the Pan-American Exposition in Buffalo. This was to be a historic occasion. Thomas Edison himself was to be on hand to officiate at an “illumination” ceremony to launch the “electrification” of the fair, where exposition-goers were to be dazzled, for the first time ever, by the light of more than 10,000 bulbs providing instant illumination at the flick of a switch.

The United Electrical Contractors of New York State decided to make the event even more historic. They sent out a call for representatives of all the electrical contracting associations across the nation to join their convention to explore the possibility of establishing a national organization. The call was answered by 49 contractors from 18 cities in eight states – New York, Maryland, Missouri, Minnesota, Michigan, Massachusetts, Ohio and Pennsylvania. The prime motivation for these 49 contractors to join together was the problem of electrical installations by a wide variety of businessmen without a common code of ethics or protocol. The men who met in Buffalo wanted to create an industry. They were struggling to establish an identity for their trade.

Shortly after 2:00 p.m. on July 17, 1901, this group meeting in the New York State Building on the exposition grounds had ratified into being the National Electrical Contractors Association of the United States. The allied contractors went on to elect the association’s first national officers, with Charles L. Eidlitz of New York City chosen as the association’s first national president. The group settled on Utica, NY, as home to the association’s first national headquarters. A constitution and bylaws also were adopted. As set forth in that first constitution, “The objects for which this Association is formed are the fostering of trade among electrical contractors ... to reform abuses ... to settle differences between its members ... and to promote more enlarged and friendly discourse among its membership.”

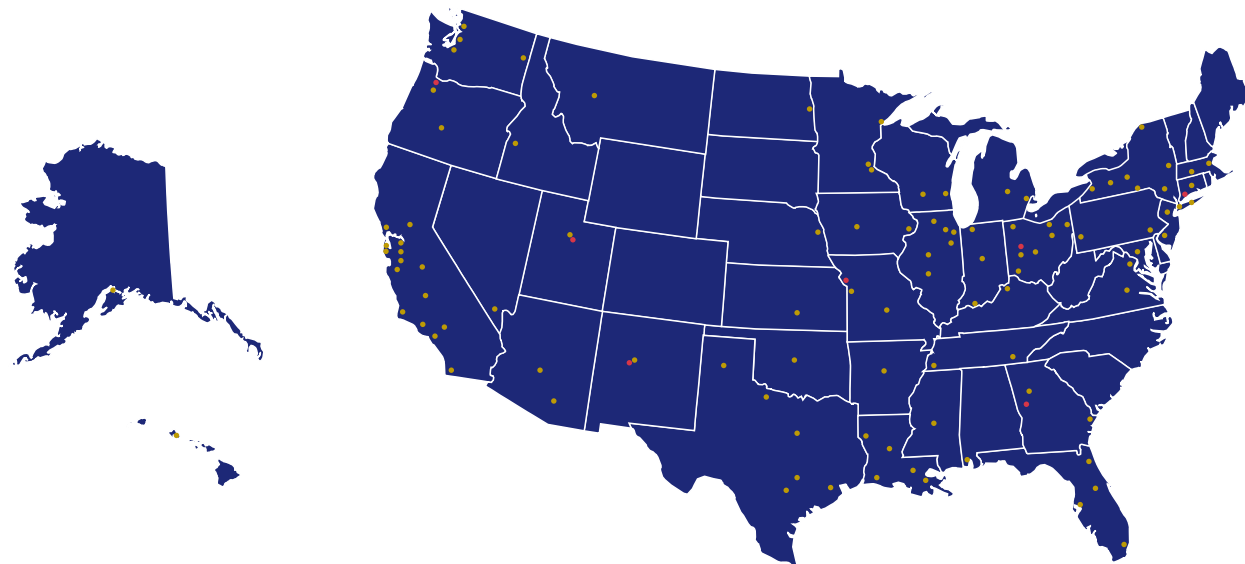
Carrying out those objectives would continue to occupy the association for the next century – and well beyond!

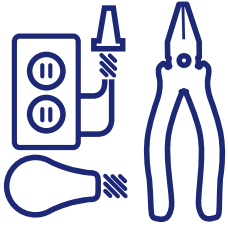

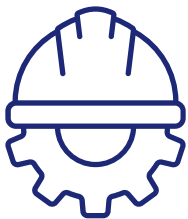

DAVID LONG

Chief Executive Officer

David Long has been in the electrical construction industry since 1975, when he began work as a construction wireman for Miller Electric. After graduating from the Jacksonville JATC in 1981, he began his career as a journeyman wireman. This led to foreman and supervisory positions. In 1991, he moved into management as an estimator and assistant project manager. He rose through the ranks at the company and was named President of Miller Electric in 2012. Long earned a bachelor's degree in business management from Southeastern University.

Long's involvement in NECA began in 1994 on the Local JATC Committee, where he served as chairman or secretary for more than 15 years. The experience gave him the opportunity to serve on the Electrical Training Alliance Curriculum Committee and then on NECA's Workforce Development Committee as a member of the Electrical Training Alliance Committee.

Long is seen as a leader throughout the electrical construction industry. He was Governor of NECA's North Florida Chapter and, on the national level, served as District 3 Vice President. He has chaired the Workforce Development and Compensation committees and co-chaired several organizations including the electrical training ALLIANCE, Council on Industrial Relations, National Labor Task Force, and the National LMCC Committee. He was awarded the Coggeshall Award in 2012 and was installed into the Academy of Electrical Contracting in 2012. In 2018 David Long was elected President of NECA and in 2019 he was selected to serve as Chief Executive Officer.



TRACI WALKER

Treasurer, Chief Financial Officer

Traci Walker joined NECA staff in 1999 as Controller and was promoted to Secretary-Treasurer in 2012. In this position, she is responsible for the membership and financial records of the association's 4,500+ member firms in 117 local chapters and an annual budget of \$48 million.

Prior to joining NECA, Traci worked at a public accounting firm that performed NECA's annual audits and tax work. Traci earned her bachelor's degree in business administration from the University of Richmond and passed the Certified Public Accounting exam.



MARK WALTER

President, NECA

Christenson Electric Inc.

Mark Walter is in his first term as President of NECA and is currently the President of Christenson Electric Inc. in Portland, Oregon. In 1987, Walter began his career at Christenson Electric and worked within the Utility and Industrial Group for 5 years. He then took advantage of a management opportunity with a Spokane based contractor named Power City where he worked as their HV Division Manager and was promoted to Operations Manager. When he returned to Christenson Electric, as President, in 2003, the company was in financial trouble. In 2007, after making corrections to stabilize and balance the organization, he made an offer to purchase the company. That became a reality in 2008. Although most of Christenson's work occurs in Northern Oregon and Southwestern Washington areas, renewables and energy work is performed across the entire United States.

Walter has been active with NECA since the mid-1990s. Early involvement was with the NECA Northwest Line Chapter, where he held board positions and served as Governor. Since working as CEO, Walter has gotten more involved with the Oregon-Columbia Chapter, serving in various board positions and as Governor. He has been a member of the Political Leadership Council since 2020 and active on the Council of Industrial Relations since 2018. Walter received the Comstock Award in 2019 for his contributions to labor relations, leading to his induction into the Academy of Electrical Contractors that same year. Most recently, Walter served as Vice President of District 6 before becoming President of NECA.



JEF FAGAN

Chief Operating Officer

James (“Jef”) Edward Fagan, III is NECA’s Chief Operating Officer. Fagan was previously Senior Vice President of Labor Relations and Risk Management. He was originally hired as NECA’s first General Counsel in 2019, and in addition to shaping the internal legal functions at NECA, he built out its Risk Management Team in 2020. As a 30-year labor, employment, and litigation attorney, Fagan has extensive experience in traditional labor matters and risk management, and his mature and measured leadership style sets NECA up for success as he leads his departments and guides national policies for the electrical contracting industry.

Marco Giamberardino is Chief Communications Officer for the National Electrical Contractors Association (NECA). Previously, Giamberardino served as Senior Vice President, Government Affairs and Public Relations.
